Please note that, not all Porsche 911 Carrera and Carrera 4 vehicles produced during the above production period were originally equipped with the standard rear muffler exhaust system. Many of the vehicles produced were equipped with the optional sport exhaust system, which is unaffected by this recall. Affected by this recall are 100% of the vehicles produced in the above production period equipped with the standard rear muffler exhaust system.

Description of Defect

Internal quality testing has revealed that the rear mufflers of the standard muffler exhaust system that were installed during the affected production period do not achieve the required service life.

As a result, the exhaust tailpipe of the rear muffler can fracture on vehicles with higher mileage. This can subsequently result in the separation and loss of the exhaust tail pipe.

Basis for Determination

May 2012

The first fracture was observed in the circular welded seam on the rear muffler of an internal test-vehicle manufactured during the affected production period.

May 2012 to January 2013

Porsche and the involved supplier conducted internal inspections and component testing. As a remedial measure, reinforced components were developed and endurance tested.

February 2013

Porsche is not aware of any defects or reported failures on any customer owned vehicles. All defects determined to date were reported on internal Porsche test vehicles with higher mileages (>25,000 miles).

Porsche is not aware of any accidents or injuries resulting from the defect described here.

Due to the problem Porsche has detected on high-mileage test vehicles, Porsche has decided to conduct a safety recall and replace the components with reinforced rear mufflers.
