Once the customer has been notified by Audi, Mercedes, Porsche of Albuquerque that their custom ordered vehicle has arrived, the customer will have 10 days to consummate the transaction, to include, payment in full and signing of all documents. Should the customer fail to consummate the transaction within 10 days, customer acknowledges their deposit will be forfeited and their vehicle offered for re-sale to other prospective buyers.

Should Audi, Mercedes, Porsche of Albuquerque fail to deliver the customer's custom order for any reason, the \$5,000 deposit will be refunded.
