ARBITRATION AND MEDIATION

The Parties hereto agree that any and all *claims*, controversies or disputes arising from or related to this Agreement, including, but not limited to those claims, controversies or disputes pertaining to the formation, construction, performance, applicability, interpretation, enforceability, or breach of this Agreement, or any claim or assertion that all or part of this Agreement is void or voidable, shall be settled by binding arbitration according to the rules of Maryland Bar Association [if good faith negotiations among the parties do not resolve such claim, dispute or other matter within 60 days and the parties have not elected to submit such claim, dispute or other matter to mediation]. Further, venue for the arbitration proceeding shall be in the City of College Park MD. In the event the City of College Park MD, is unable hold an arbitration case, then another location within Prince George's County will be selected by Lotus Ltd. The Parties hereto also agree that any *award* tendered by the arbitrator may be entered as a judgment in the Prince George's County District Court and enforceable as an *order* of said court and the Parties hereby submit to the venue and jurisdiction of that court for purposes of enforcement of any arbitration award. The arbitrator's decision shall be final and legally binding and judgment may be entered thereon.

Damage Waiver

Any physical damage done to the track or track facilities are solely the financial responsibility of
the party deemed, by the track marshals, track director or Lotus Ltd, to have caused the damage.
Lotus Ltd. is not financially liable for any damage to the track or track facilities caused by any
participant of a Lotus Ltd. event.
